1 AUTHORITY

The 21st South East Asian Junior & Cadet Table Tennis Championships (SEA JC TTC) will be hosted by the Table Tennis Association of Malaysia (TTAM) under the authority granted by the South East Asian Table Tennis Association (SEATTA).

8 SYSTEM OF PLAY

8.1 Junior Team Events

The team competition will be conducted in two (2) stages

Teams will be divided into two (2) groups to play a Round Robin System to determine the group winners

8.1.2. Stage 2

The top two (2) teams from each group will play a Knockout System to determine the positions of 1st, 2nd, 3rd and 4th

Order of Play A vs X, B vs Y, C vs Z, A vs Y, B vs X

All team matches shall be best of five (5) games

If the number of participating teams is less than 6, the teams will play a Round Robin System to determine the winners.

8.2. Cadet Team Events

The team competition will be conducted in two (2) stages

8.2.1. Stage 1

The teams will be divided into two (2) groups to play a Round Robin System to determine the group winners.

8.2.2. Stage 2

Top two (2) teams from each group will play a Knockout System to determine the winners.

Order of Play A vs X, B vs Y, Double, A vs Y, B vs X

All team matches shall be best of five (5) games

If the number of participating teams is less than 6, the teams will play a Round Robin System to decide the winners.

8.3. Single Events

The Singles competition will be conducted in two (2) stages.

8.3.1. Stage 1

Players will be divided into groups depending on the number of entries to play a Round Robin System to determine the group winners.

8.3.2. Stage 2

Group winner/winners shall play a Knockout System to determine the winners.

The matches shall be best of five (5) games, except Semi-Finals and Finals matches shall be best of seven (7) games.

8.4. Doubles Events

All double events to be played in a Knockout System to determine the winners.

All double matches shall be best of five (5) games.

One player is entitled to participate in only one age group for each event.

9 SEEDING

- 9.1. Seeding for teams and players shall be based on the results of the 20th SEA JC TTC 2014.
- 9.2. In the event teams or players not included in the result list, the latest ITTF ranking shall be taken into consideration.
- 9.3. The seeding list shall furnished by the SEATTA Technical Committee Chairman who shall advise the organizing Committee on the preparation of the draw.

The Jury shall consist of the following:-

- 14.1. A Chairman appointed by the SEATTA Technical Committee
- 14.2. SEATTA Technical Committee Members
- 14.3. SEATTA Rules Committee Chairman
- 14.4. One representative from the Organizing Committee
- 14.5. Three (3) Team Managers whose teams are not involved in the dispute
- 14.6. The Referee who shall have the right to speak but not to vote

15 HOSPITALITY

The Organizing Committee will provide free hospitality to the teams from dinner on 16.6.15 to breakfast on 22.6.2015 as follows:

- 15.1. 3 Junior boys, 3 Junior girls, 1 Cadet boy, 1 Cadet girl and 1 official
- 15.2. Same hospitality shall be provided for all members of the SEATTA Executive Committee, Technical Committee, Rules Committee Chairman and SEATTA staff invited by the host.
- 14.4 Same hospitality shall be provided for extra participants at a cost of USD100 per day per person for twin sharing room or USD135 per day per person for single room.
- 14.5. The expenses for the travelling, hospitality and allowance of the Technical Delegate and Referee appointed by SEATTA shall be borne by the Organizing Committee.

15 LAWS OF TABLE TENNIS AND REGULATIONS FOR INTERNATIONAL COMPETITIONS

Except for those provided aforesaid, the latest Laws of Table Tennis & Regulations for International Competitions in the ITTF Handbook shall be adopted in the Championships.
